## **ORDINANCE NO. 12-3-23**

AN ORDINANCE OF THE CITY OF BROMLEY CLOSING A PUBLIC WAY, 115 MOORE STREET, BROMLEY, KENTON COUNTY, KENTUCKY PURSUANT TO KRS 82.405

WHEREAS: KRS 82.405 PERMITS THE CLOSING OF A PUBLIC WAY UPON WRITTEN NOTICE OF THE PROPOSED CLOSING TO ALL PROPERTY OWNERS ABUTTING THE PARCEL TO BE CLOSED AND THE RECIEPT OF WRITTEN AND NOTORIZED CONSENT FROM THOSE ABUTTING PROPERTY OWNER, AND

WHEREAS: THE CITY OF BROMLEY HAS PROPOSED CLOSING THE PUBLIC WAY WITH THE ADDRESS OF 115 MOORE STREET IN THE CITY OF BROMLEY WHICH WAS CONVEYED TO THE CITY OF BROMLEY BY DEED RECORDED IN DEED BOOK 272, PAGE 41 OF THE KENTON COUNTY CLERKS RECORDS AT COVINGTON, KENTUCKY AND WAS ASSIGNED A PIDN NO. OF 026-42-01-015.00, AND WHICH IS MORE PARTICULARLY DESCRIBED IN EXHIBIT A, ATTACHED HERETO AND INCORPORATED HEREIN BY REFERENCE, AND

WHEREAS: IT HAS BEEN DETERMINED THAT THE ABUTTING PROPERTY OWNERS OF THE PUBLIC WAY ARE LARRY WARTMAN, CHRIS WARTMAN AND THE TIMOTHY WARTMAN LIVING TRUST, AND

WHEREAS: THE ABUTTING PROPERTY OWNERS HAVE RECEIVED WRITTN NOTICE OF THE PROPOSAL TO CLOSE THE PROPERTY REFERRED TO HEREIN AND HAVE ALL GIVEN WRITTEN AND NOTORIZED CONSENT TO THE PROPOSED CLOSING, WHICH ARE ATTACHED TO THIS ORDINANCE, AND

WHEREAS: ALL OF THE CONDTIONS NECESSARY PURSUANT TO KRS 82.405 (1) AND (2) TO CLOSE THE PUBLIC WAY REFERRED TO HEREIN HAVE BEEN MET, AND

WHEREAS: THERE IS A CEMETARY ON THE REAL ESTATE ABUTTING THE PUBLIC WAY TO THE SOUTH AND ANY CONVEYANCE OR TRANSFER OF THE PUBLIC WAY AFTER ITS CLOSING WILL INCLUDE THE RETENTION OF ANY RIGHTS OF INGRESS AND EGRESS FOR PERSONS LEGALLY ENTITLED TO ACCESS THE CEMETARY AS THEY MAY NOW EXIST,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF BROMLEY, KENTUCKY:

## **SECTION I**

That the public way with a street address of 115 Moore Street, Bromley, Kenton County, Kentucky and which is more particularly described in Exhibit A, attached hereto and incorporated herein by reference as if fully set forth, be and is hereby closed as a public way and upon the effective date of this ordinance the City shall transfer the property as provided for by law and any such transfer or conveyance shall be made subject to the potential rights of ingress and egress described above related to the cemetery referred to above.

## **SECTION II**

All ordinances in conflict herewith are to the extent of such conflict repealed.

#### **SECTION III**

The invalidity of any section, subsection, or sentence or the ordinance shall not affect the remainder.

### **SECTION V**

This Ordinance shall take effect and be in full force from and after its passage. approval, and publication, according to law.
