- 1) Phase One The contractor will be responsible for cleaning the asphalt of loose rock, debris and vegetation on these listed streets before sealing. This will be considered phase one of multi phases to allow flow of traffic during sealing.
 - a. Shelby Street 1600 LF. X 30' wide.
 - b. Steve Tanner Street 1200 LF. X 30' wide
 - c. Rohman Street 1200 LF. X 30' wide.
 - d. Hayward Street 500 LF. 15' wide.
- 2) **Phase Two** of this project shall include cleaning the asphalt of loose rock, debris and vegetation on these streets before sealing. This will be considered phase Two of the multi phases to allow flow of traffic. (**Phase Two cannot start until after July 1, 2022.**)
 - a. Pleasant Street 700 LF. X 30' wide.
 - b. West Oak Street 350 LF. X 30' wide.
 - c. Lake Street 200 LF. X 30' wide.
 - d. Kenton Street 900 LF. X 30' wide.
 - e. Moore Street 1200 LF. X 30' wide.
 - f. Boone Street 1200 LF. X 30' wide
 - g. Short Boone Street 400 LF. X 30' wide.
- 3) Phase Three of this project is Concrete Joint Seal and shall include cleaning the concrete of loose rock, debris and vegetation on Short Street 350 LF. X 15' wide.
- 4) The contractor will be responsible for maintaining as much residential parking as possible while working on the city streets.
- 5) Bidder will need to provide one reference along with proof of insurance for at least \$500,000.
- 6) **Final Phase** Re stripe existing crosswalks and stop bars on streets and intersections that have been sealed.
 - a. Contractor will need to re-paint parking divider lines along the 200 Block of Boone Street.
- 7) Apply asphalt poly-seal, with DSF additive to allow longer life of sealer Block each section off for 24 hours to dry.

Bidders will indemnify and hold the city harmless from any loss, claim or damage arising from any action or failure to act by the bidder or any of their agents, employees or representatives in relation to the performance of activity connected to this bid.
